| <p>The aim of the module is to develop your knowledge and understanding of some of the key legal issues arising from the mining sector. It provides an overall overview and general understanding of the legal and regulatory framework governing the mining sector, issues relating to large scale mining and Artisanal and small-scale mining, digitalisation in the mining sector, licencing regime, the various mining contracts. The module also addresses the role of critical minerals and the mining sector for the global energy transition, and the social, environmental and governance issues associated with mining.</p> |

| <p>Introduction to the basic concepts of the mining industry: basic contractual issues, operation, assignment.</p> <p>Ownership, phases of mineral exploration and development; the legal and regulatory framework including the different generation of mining laws; contractual arrangements and licences.</p> <p>Artisanal and Small-Scale Mining; Digitalisation in the mining sector.</p> <p>Critical minerals, the mining sector and the global energy transition.</p> <p>Environmental, social and governance challenges in mining; local content and acquiring a social licence to operate; mining disputes and resolution; mining closure and rehabilitation.</p> |

| Learning, Teaching and Assessment Strategy |

| <p>A range of methods will be adopted to direct and support learning on this module. This module will be delivered across Semester 1 and is composed of the following, spread over the semester:</p> <p>22 hours face to face lectures. 11 hours face to face tutorials.</p> <p>You will attend a weekly two-hour face to face lecture. For each of the lectures you will be asked to carry out some preparatory work which will include reading articles, book chapters and primary legal materials. Your preparation will also include independently researching questions set. The tutorials will be organised every two weeks to discuss the main issues and respond to the questions covered in the main lectures.</p> <p>During the lectures there will be some lecturer input and you will be asked to discuss your preparation and work in groups or individually to critique additional materials, debate questions and analyse primary law. There will be follow up work after most lectures to consolidate your learning and help you develop the criticality required at this level.</p> <p>Your work will be supported, and you will have access to the relevant materials in our library. Oral feedback will be given in the class and opportunities for written feedback will be provided. Tutors will be available to meet you individually if requested to discuss further feedback opportunities and review your progress.</p> <p>Assessment will be by coursework only. This will comprise a written essay-based coursework of 4000 words or equivalent. This will ensure that you are able to apply legally based reasoning to answer conflict-based questions. You will be required to undertake a critical analysis of complex issues in this field applying the principles and law studied in this module. The coursework will require the use of independent research, critical and analytical skills. You will also be expected to use appropriate legal terminology and written communication. The summative assessment is aimed at testing your ability to meet the learning outcomes of the module, while the formative assessment is aimed to monitor the students learning and offer feedback.</p> |
